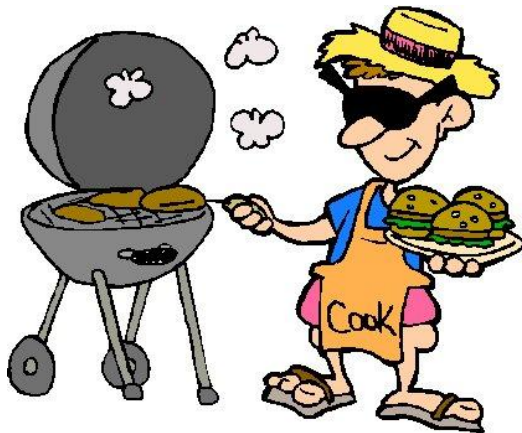

While still moving boxes into the house, Sigrid came over and invited me to come to a Social Committee meeting the next week and I was hooked just that easily. I guess in the world of fish, I'm a perch.

Within a week, Jack Hamilton and Lisa Steinback visited me for an interview and welcome visit respectively. Jack planted the seed of my joining Membership Committee and then carefully worked to cultivate the idea over the next six months. Soon I was ripe for the picking. In the world of fruit, I must be low hanging.

Over the next years, I got interested in the Emergency Response Committee, though I confess that I was never as helpful as I should have been. I like participating though. It makes me feel connected to my neighbors and forces me out of my normal routine once in a while.

Committees play an important role in GMCA. They are the voice of the association, the workhorse of the community and the liaison between the Board and the members. If our committees are weak, then either the association suffers or the Board is left trying to do it all. 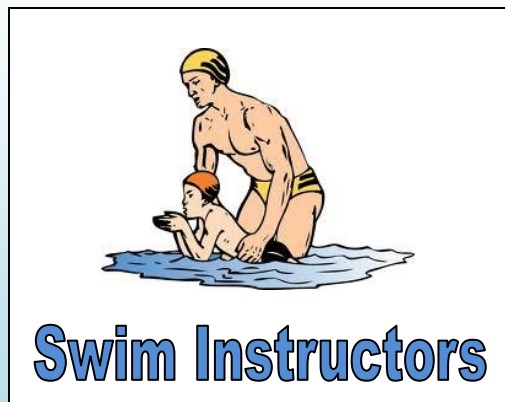
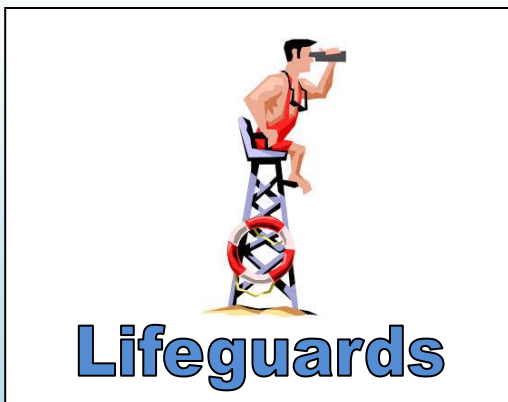

# GMCA Board Meeting Minutes

March 11, 2013

Attendees: Sean, Velu, Carol, Jeff, Lisa, Chris and Patrick

Guest: Jeff Kmetec, Finance Committee and Tim Foy, GM20NOW Committee

Motion to approve Feb. meeting minutes as published in *Meadowlark* — passes unanimously

- 1) Discussion of guest policy:
  - a. Lisa will check pool brochure in membership packet for guest policy statements.
  - b. Lisa will ask Membership Committee to clarify guest policy if needed.
- 2) Membership Committee (MC) — Lisa
  - a. MC will be sending email receipts from Gnosis DB to all paid up 2013 members.
  - b. New Member BBQ is scheduled for May 5.
  - c. Now that the Marlins coaches have been announced, Board requests that MC add more swim team-related posters at the local schools.
  - d. Lisa will ask Membership Committee to provide guidance on partial payments for special cases.
  - e. Residents that have moved outside GM are requesting to join as “social members” only. Board is in favor (6 votes yes, 1 vote no) of creating a new membership category which would be “non-voting fairshare.” Membership Committee to discuss a possible new category to handle that request.
- 3) Santa Clara Swim Club (SCSC) status — Carol Turner
  - a. SCSC started working at GMCA on 3/11/13.
  - b. Web-based TeamUnify will be used for purchasing swim lessons, as well as paying for swim team.
  - c. Sean will provide SCSC with names of locals who have worked as assistant swim coaches and lifeguards so SCSC can contact them.
- 4) GM20NOW status — Velu Sinha
  - a. Tim Foy and Aimee Jose have requested that the Board retain legal counsel to provide opinion on GMCA voting rights, as defined in Articles of Incorporation and By-Laws.
  - b. Velu will speak to two recommended lawyers and request that they meet with the Board to provide introduction.
  - c. Board members expressed concern over hiring a lawyer until there is a specific question to be answered.
  - d. GM20NOW Committee is meeting on Wed., 3/13 at 7 pm.
  - e. Jeff Kmetec and the Finance Committee met on 3/11 to brainstorm ideas for financing the GM20NOW project.
- 5) Part-time GM office manager
  - a. Board has a job description.
  - b. Position will be a 1099 vendor.
  - c. Sean will ask SCSC if they have a person on their staff who does office admin tasks.
  - d. Hourly pay rate TBD.
  - e. Two candidates have expressed interest so far.

## San Antonio Center Development Update

Penny Ellson shared an update on the latest proposals for additional redevelopment at San Antonio Center in Mountain View. Visioning process for redevelopment is complete. MV City Council has directed staff to move forward with individual developer project plans before completing a Precise Plan. Palo Alto Mayor Scharff has agreed to open a conversation at GMCA's request with Mountain View Mayor and staff about potential spillover transportation impacts of the projects in south Palo Alto.

## The Future of Cubberley

Lanie Wheeler, GMCA Civic Affairs' representative to the Cubberley Community Advisory Committee (CCAC), gave an update on the work of the committee and asked for feedback from the community on the probable direction of the committee recommendations. She provided an historical overview of the site's ownership and lease agreement with PAUSD. The 35-acre site is Palo Alto's last public owned parcel with potential for facilities redevelopment. PAUSD owns 27-acres which are currently leased to the city. The city owns the remaining 8 acres. The city sublets the building facilities and playing fields to organizations that provide community services. The site gets an estimated 600,000+ visitors per year. She pointed out that the site's accessibility to schools and neighborhoods via walking, biking and transit make it especially valuable for PAUSD and community service uses.

She described the many community uses, including: education, child care, arts, and sports. Each of these program cluster groups have formed communities that reside at Cubberley and support each other. She reported on results of a recent Cubberly tenant survey which indicated that if Cubberley were not available to them, 25% would no longer be in operation. The remainder would relocate –most of those would have to move out of Palo Alto for affordable rental rates.

The city is finding the \$7 million lease payment a challenge. The city needs certainty about the future use of Cubberley to justify a \$18 million deferred maintenance expenditure. They would like to start planning now with PAUSD to ensure long-term availability of playing fields and community services. If PAUSD requires all 35 acres, relocating City services and sport programs will be very difficult and program reductions would be necessary.

PAUSD is dependent on the Cubberley lease revenue stream. Further, it is challenging to accurately project enrollment beyond 5-7 years. Assuming continuation of the current 2%/year enrollment growth, we might need a third comprehensive high school in 15-20 years. They want flexibility to reclaim the entire 35 acres, including the city's 8 acres. They have stated they might use the existing buildings "as is."

### *Options being explored:*

#### ***1: Preserve Cubberley for PAUSD***

This option will continue city community center playing field use for less than 15-20 years (to allow time to redevelop the site for school use) and provide short-term revenues for PAUSD. In 2027-2032 PAUSD could open a third comprehensive

high school in a 70-year old facility. Costs of this option include:

- \$2.21m annual expenses
- \$330k current Maintenance costs (however, it is estimated that this amount should be closer to \$800k annually)
- \$18.8m planned CIP & deferred maintenance through 2036
- Unknown cost of renovating for eventual PAUSD use.
- Unknown location/cost for replacement city fields and community service facilities.
  - Purchasing new real estate for community services in an alternate location is already cost prohibitive.
  - Alternate site options for community facility development and fields reduce over time.
  - The longer we wait, the more options we lose.

## **Option 2: Co-location or Shared Use**

Lanie presented a chart analysis (which cannot be reproduced in the *Meadowlark*) of the existing land use on the site. In summary, the analysis revealed that site use breaks down as follows:

13 acres	Fields & Tennis Courts
7.8 Acres	“Site” (landscaping, courtyards)
4 acres	Buildings
2.7 acres	Circulation (sidewalks, covered walkways—covered, dark tunnel-like breezeways which prevent light from entering buildings and require expensive roof maintenance.
2 acres	Access Roads
5.5 acres	Parking Lots

One proposed option considers redeveloping the whole site for co-located or shared City and PAUSD use by moving parking below grade, improving building, site, circulation efficiency. This could “repurpose” 9.4 acres—providing room for co-located uses. Co-location could:

- optimize use of prime public land that is ideally located for community members served by both CPA and PAUSD.
- Improve PAUSD and CPA flexibility to respond to the “enrollment roller coaster” by

providing a facility the city and PAUSD could share as needed.

- provide certainty of future use by the city--justifying CPA investment in the facility
- Providing space for 9-12 education, community services, and playing field facility needs of a growing population. It could also maximize potential for cost efficiencies through synergies of shared or co-located facilities.

A partnership commitment by PAUSD & CPA to work together cooperatively and an assessment of current and future community needs and services would be needed to realize this vision. Lanie asked for guidance from the community about their interests and presented DRAFT guiding principles for discussion:

*GM community believes that Cubberley should be retained as a resource to meet the educational, community services and recreational needs in a walkable/bikeable location for future generations of Palo Altans.*

1. *In order to accomplish the above, we support the following:*
    - *Renewal of the Cubberley lease between the City and the School District*
    - *Completion of a Community Needs Assessment to provide reliable data for accommodating community services and recreational needs on the site*
    - *Adoption by the City and the School District of a Memorandum of Understanding which would address the long-range planning and the governance of the site*
  2. *We recognize that for these plans to be realized it may require:*
    - *The construction of 2 to 2 ½ story buildings on some portion of the site*
    - *The provision of underground or partially underground parking*
    - *The passage of a joint or two separate bond measures to finance the necessary construction of the site*
    - *A carefully conceived traffic management plan*
